PROPOSED SIXTY-BED ELDERLY PERSONS HOME AND FIFTEEN PLAY DAY CENTRE PART OF FORMER HALSEY SCHOOL SITE LAND OFF CHERRY ORCHARD, HEMEL HEMPSTEAD Conditions to be attached to planning permission (application 4/86-96)

1. DRAINAGE

Before the development hereby permitted is commenced, details of the surface water drainage works shall have been submitted to and approved in writing by the Local Planning Authority in consultation with the National Rivers Authority.

Reason: In accordance with the requirements of the National Rivers Authority to ensure that there is no increased risk of flooding.

2. **LANDSCAPING**

The development hereby permitted shall not be commenced until a full landscaping scheme for the site has been submitted to and approved in writing by the County Planning Authority, the scheme to be based on the layout indicated in drawing number 489/05/008 but amended to include details of all the boundary treatment and with the plant species and specification list related to the layout shown in the drawing. All landscaping required by the scheme shall be completed before any part of the development hereby permitted is occupied, unless this period is extended in writing by the County Planning Authority or unless the approved scheme specifically provides an alternative timetable. Any tree or shrub which dies or is severely damaged within five years of planting shall be replaced during the first available planting season to the satisfaction of the County Planning Authority.

Reason: To ensure the adequate and satisfactory landscaping of the site in the interests of the amenity of the area.

3. ACCESS FOR CONSTRUCTION TRAFFIC

All construction traffic shall enter the site via the existing school access off Polehanger Lane. There shall be no access for construction vehicles off Cherry Orchard.

Reason: In the interests of the amenity of residents in Cherry Orchard and adjacent residential streets which would not be suitable for heavy construction vehicles bringing large prefabricated components to the site.
