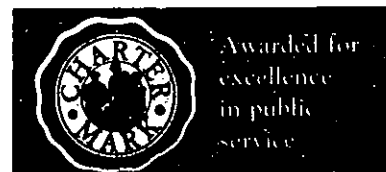

**ERECTION OF SINGLE MOBILE CLASSROOM UNIT  
THOMAS CORAM MIDDLE SCHOOL, SWING GATE LANE,  
BERKHAMSTED  
Two conditions to be attached to planning permission (4/189-97)**

1. **COLOUR**

The unit hereby permitted shall be painted a similar brown colour to the fascia boards on the existing school building.

**Reason :** In order that the unit may better relate to the existing school in visual terms.

2. **TIME LIMIT**

This planning permission shall be for a limited period of five years expiring on 30 April 2002. On or before that date the building erected under this permission shall be removed and the land cleared to the satisfaction of the County Planning Authority.

**Reason :** To enable the County Planning Authority to exercise proper control over development on this site.
