Tree Planting at Light Industrial & Storage at Woodcroft Farm Re: Water End Road, Potten End Ref. 4/0986/95/HH/JDD

Enclosed three plans of site showing landscaping scheme.

- Red boundary indicates industrial site. 1.
- Green indicates existing trees and hedges.

East side of site

50+ years - fully mature Α English Oak В 50+ years Holly 50+ years C English Oak Ash 50+ years

North side of site

Hedge - Lawson Cypress - height 15 ft - age 15 years

West side of site

Hedge - Hawthorn - height 12 ft - age 30 years

3. Blue indicates new planting

East and South East boundary

Blue X indicates individual English Oak (Quercus Robur), three in total.

These are heavy standards 100-120 m circumference, 3-4 metres high, staked with ties.

Blue line indicates screening hedge planted on bank.

Consisting of Common Dogwood (Cornus Sanguinea) Quickthorn (Crataegus Monogyna) Spindleberry (Euonymus Europaeus) Blackthorn (Prunus Spinosa) Wayfaring Tree (Viburnum Lantana) Guelder Rose (Viburnum Opulus)

These will be planted in two rows three-quarters of metre apart. The spacing down each row will be $\frac{1}{2}$ metre apart. mixture of species.

Size of species will be 60-90 m whips.

North side of site boundary

Blue line indicates screening hedge planted one metre from base of existing hedge line.

Consisting of 5 Ash (Fraxinus Excelsior) 5 Oak (Quercus Robur)

These are grown as trees spaced out down line of screening hedge.

Hedge Species - Field Maple (Acer Compestre)
Hazel (Corylus Avellana)
Holly (Ilex Aquifolium)
Common Dogwood
Quickthorn
Spindleberry
Blackthorn
Wayfaring Tree
Guelder Rose

These will be planted in two rows three-quarters metre apart. The spacing down each row will be three-quarters metre of a mixture of species.

Size of species will be 60-90 m whips.

The planting will take place immediately and be completed by end of March.

All species will be protected against farm animals and rabbits.
