2. Any advertisements displayed, and any site used for the display of advertisements shall be maintained in a clean and tidy condition to the reasonable satisfaction of the local planning authority.

3. Any structure or hoarding erected or used principally for the purpose of displaying advertisements shall be maintained in a safe condition.

4. No advertisement is to be displayed without the permission of the owner of the site or any other person with an interest in the site entitled to grant permission.

Notwithstanding the details shown by the layout design of the illumination of the canopy (Plan A), a full technical statement shall be submitted to the local planning authority demonstrating how glare, spill and the concentration of light under the canopy can be restricted in relation to the adjoining land and highway.

10. The canopy shall only be lit with the halogen system if it is satisfied that the details submitted in accordance with Condition 9 are acceptable to the local planning authority.
