1. This consent is granted for a period of five years commencing on the date of this notice.

<u>Reason</u>: To comply with the provisions of the Town and Country Planning (Control of Advertisements) Regulations 1992.

2. Any advertisements displayed, and any site used for the display of advertisements shall be maintained in a clean and tidy condition to the reasonable satisfaction of the local planning authority.

<u>Reason</u>: To comply with the provisions of the Town and Country Planning (Control of Advertisements) Regulations 1992.

3. Any structure or hoarding erected or used principally for the purpose of displaying advertisements shall be maintained in a safe condition.

Notwithstanding the details of illumination shown on Drawing No. KFC/1262/1, the fascia sign shall only be illuminated in accordance with the plan coloured red and yellow and received on 23rd May 1994, such that:-a) The opal area hatched yellow shall not be illuminated; b) The red areas hatched red shall be internally illuminated by flourescent tubes as shown by the plan.

Reason: The details of the internally illuminated fascia sign are unacceptable, due to the adverse impact upon the street scene. The restriction of the internal illumination to accord with the criteria specified by the condition overcomes the adverse impact, as agreed with the applicant.
