1. This consent is granted for a period of five years commencing on the date of this notice.

<u>Reason</u>: To comply with the provisions of the Town and Country Planning (Control of Advertisements) Regulations 1992.

2. Any advertisements displayed, and any site used for the display of advertisements shall be maintained in a clean and tidy condition to the reasonable satisfaction of the local planning authority.

<u>Reason</u>: To comply with the provisions of the Town and Country Planning (Control of Advertisements) Regulations 1992.

3. Any structure or hoarding erected or used principally for the purpose of displaying advertisements shall be maintained in a safe condition.

Reason: To comply with the provisions of the Town Planning (Control of Advertisements) Regulations 1992.

4. Where an advertisement is required under the Town and Country Planning (Control of Advertisements) Regulations 1992 to be removed, the removal shall be carried out to the reasonable satisfaction of the local planning authority.

10. The base of the pole sign as shown as hatched red on Drawing No. LCBE 101A shall not be illuminated and in the event that the section cross-hatched red is not used for the display of a poster over the whole of the cross-hatched area this section of the sign shall not be internally lit.

Reason: In the interests of amenity.

11 Notwithstanding the details shown on Drawing No. LCBE 101A, the highest part of the advertisement shall not exceed that of the adjoining petrol filling station pole sign referred to and illustrated in the details submitted with the application.

Reason: In the interests of amenity.

12. The advertisement hereby authorised shall not be displayed and this consent shall become of no effect if the advertisement for which consent was granted on 3 November 1999 for a pole sign on land adjoining McDonalds Restaurant (Ref: 4/01546/99/ADV) is at any time displayed.
