NOTE

(1) If the applicant wishes to have an explanation of the reasons for this decision it will be given on request and a meeting arranged if necessary.

(2) If the applicant is aggrieved by the decision of the local planning authority to refuse permission or approval for the proposed development, or to grant permission or approval subject to conditions, he may appeal to the Secretary of State for the Environment, in accordance with section 36 of the Town and Country Planning Act 1971, within six months of receipt of this notice. Appeals must be made on a form which is obtainable from the Secretary of State for the Environment, Marsham Street, London, S.W.1.1 The Secretary of State has power to allow a longer period for the giving of a notice of appeal but he will not normally be prepared to exercise this power unless there are special circumstances which excuse the delay in giving notice of appeal. The Secretary of State is not required to entertain an appeal if it appears to him that permission for the proposed development could not have been granted by the local planning authority, or could not have been so granted otherwise than subject to the conditions imposed by them, having regard to the statutory requirements, to the provisions of the development order, and to any directions given under the order.

(3) If permission to develop land is refused, or granted subject to conditions, whether by the local planning authority or by the Secretary of State and the owner of the land claims that the land has become incapable of reasonably beneficial use in its existing state and cannot be rendered capable of reasonably beneficial use by the carrying out of any development which has been or would be permitted, he may serve on the Common Council, or on the Council of the county borough. London borough or county district in which the land is situated, as the case may be, a purchase notice requiring that council to purchase his interest in

the land in accordance with the provisions of Part IX of the Town and Country Planning Act 1971.

- 5. The boundary fences shown on Drawing No. 1117/1 Revision E shall be provided prior to the occupation of the barn hereby permitted.
- 6. The development shall not be brought into use until the proposed access has been constructed and the existing access has been closed and the verge reinstated to the current specification of H.C.C. and to the local planning authority's satisfaction.
- 7. Concurrent with the construction of the access visibility splays of 2.4 x 45 m shall be provided and permanently maintained in each direction within which there shall be no obstruction to visibility between 600 mm and 2.0 m above carriageway level.
- 8. The existing trees and hedges shown on Drawing No 1117/1 Revision E shall be retained and adequately protected to the satisfaction of the local planning authority for the duration of development and shall not be wilfully damaged or destroyed, uprooted, felled, lopped or topped during that period without the previous written consent of the local planning authority. Any trees or parts of the hedge removed without such consent or dying or being severely damaged or becoming seriously diseased during that period shall be replaced with trees and hedges or such size and species as may be agreed with the local planning authority.
- 9. Notwithstanding the provisions of the Town and Country Planning Development Order 1988, or any amendment thereto, there shall be no additional openings formed within the roofs and all elevations of both converted barns, or any extensions to the respective units hereby permitted without the express written permission of the local planning authority.
- 10. Notwithstanding the provisions of the Town and Country Planning General Development Order 1988, or any amendment thereto, there shall be no fences or walls erected within the courtyard surrounded by residential units 'A' to 'D' shown on Drawing No 1117/1 Revision E without the express written permission of the local planning authority.
- 11. Notwithstanding the provisions of the Town and Country Planning General Development Order 1988, or any amendments thereto, there shall be no vehicular hardstandings formed within the courtyard surrounded by units 'A' to 'D' shown on Drawing no 1117/1 Revision E without the express written permission of the local planning authority.

- 12. Vehicular access to Hollybush Farm shall be only from that shown on Drawing No 1117/1 Revision E.
- 13. This permission does not relate to the insertion of the window coloured yellow on Drawing No. 1047/2 Revision G.
