PLANNING (LISTED BUILDINGS AND CONSERVATION AREAS) ACT 1990 - SECTION 82 APPLICATION FOR LISTED BUILDING CONSENT

I am directed by the Secretary of State for the Environment to refer to your letter of 3 June 1993 regarding your application for listed building consent in respect of the alteration to the existing box office at the Arts Centre, Old Town Hall, High Street, Hemel Hempstead, Hertfordshire. The application was made in accordance with the provisions of Section 82 of the Planning (Listed Buildings and Conservation Areas) Act 1990.



- i) The works hereby permitted shall be begun within 5 years from the date of this letter.


