Extension to Dacorum Civic Centre, Hemel Hempstead.

The planning application dated 15th January, 1979 which was formally registered and entered in the public register on 26th April, 1979 and clarified by your letter of 25th May, 1979 was considered by the Development Control Committee on 6th June, 1979. They passed the "second resolution" under Article 5(4) of the Town and Country Planning General Regulations 1976 to carry out the development and so claimed "deemed permission".

This letter constitutes formal notification of that decision.

Members expressed some reservations on the detailing of the fenestration, particularly on the stairway of the six storey block and requested that further consideration be given to this particular aspect. This will, of course, be referred to the Working Party for discussion with your goodselves.
