You are hereby given notice that the proposals set out therein do decrees constitute development within the meaning of the said Act, and therefore

(a) planning permission must be obtained before any such proposals can be carried out

The grounds for this determination are as follows:

The formation of (a) a paved area and (b) the vehicular access are engineering operations within the definition of the Planning Acts and Regulations and require consideration.

The installation of a mezzanine floor is NOT development and does not require the submission of an application.

The erection of a canopy and insertion of additional doors and windows can be regarded as development permitted under Class VIII (i) (iv) of the Town and Country Planning General Development Order 1977 PROVIDED formal application is first made for the deletion from the permission granted to Tie Weaving Industry Ltd in October 1973 of a condition requiring the occupation and use of the extension building to be only in association with the existing premises (condition 6 - reference H/O467/73) a copy of which is attached for information.

NOTES

- (1) Any person who desires to appeal -
 - (a) against a determination of a local planning authority under Section 53 of the Act; or

shall give notice of appeal to the Secretary of State within six months of notice of the decision or determination or of the expiry of the appropriate period allowed under Article 7 (6) of the Town and Country Planning General Development Order 1977 for giving such notice (i.e. 8 weeks from date of receipt of application by Local Planning Authority), as the case may be, or such longer period as the Secretary of State may at any time allow. The notice shall be given in writing, addressed to The Secretary of State for the Environment, Tollgate House, Houlton Street, BRISTOL BS2 9DJ.

- (2) Such person shall also furnish to the Secretary of State a copy of the following documents:-
 - (i) the application
 - (ii) all relevant plans, drawings, particulars and documents submitted with the application:
 - (iii) the notice of the decision or determination, if any;
 - (iv) all other relevant correspondence with any local planning authority.
