In pursuance of their powers under the above-mentioned Acts and the Orders and Regulations for the time being in force thereunder, the Council hereby refuse the development proposed by you in your application dated 11th May 1984

17th May 1984 (amended 1st August 1984) and shown on the plan(s) accompanying such application.

The reasons for the Council's decision to refuse permission for the development are:-

(1) The site is within the Metropolitan Green Belt on the approved County Structure Plan and the adopted Dacorum District Plan wherein permission will only be given for the use of land, the construction of new buildings for agricultural or other essential purposes appropriate to a rural area, or small scale facilities for participatory sport or recreation. No such need has been proven, and since the development involves the change of use of a substantial area of rural open land to residential curtilage, the proposed development is unacceptable in the terms of this policy.

(2) The proposed dwellings by reason of their siting would conflict with Policy 6 of the Dacorum District Plan which states inter alia, that replacement dwellings in the Green Belt will normally only be permitted where the new dwellings will not be more intrusive in the landscape.
