1. The works to which this consent relates shall be begun within a period of five years commencing on the date of this notice.

Reason: To comply with the provision of s.18 of the Planning (Listed Buildings and Conservation Areas) Act 1990.

2. All new windows shall be single glazed with no top hung vents unless otherwise agreed in writing with the local planning authority.

<u>Reason</u>: In the interests of preserving the character and appearance of the building.

3. Prior to the commencement of the development hereby permitted details of the materials to be used to form the patio area to the rear of the garden room shown on Drawing No. 2116 CD/1 A LA Ref 4/0670/96LB shall be submitted to and approved by the local planning authority and the development hereby permitted shall be carried out in the materials so approved.

Reason: To ensure a satisfactory appearance.

4. The brick retaining walls shown on Drawing No. 2116 CD/1 A LA Ref 4/0670/96LB shall be constructed in brickwork to match both in colour and texture those of the existing garden room, unless otherwise agreed in writing with the local planning authority.

Reason: To ensure a satisfactory appearance.

5. The new oak post referred to in Point 2 on Drawing No. 2116 CD/1 A LA Ref 4/0670/96LB shall be dated or distinguished as a new insertion in a manner that shall be approved in writing by the local planning authority.

Reason: In the interests of preserving the character and appearance of the building.

6. All works shall be carried out in accordance with the Schedule of Works set out on Drawing No. 2116 CD/1 A LA Ref 4/0670/96FH.

Reason: In the interests of preserving the character and appearance of the building.

7. The existing tie beam in the sitting room wall shall be retained in situ and fully protected to the satisfaction of the local planning authority throughout any building or investigative operations.
