PLANNING (LISTED BUILDINGS AND CONSERVATION AREAS) ACT 1990 - SECTION 82 APPLICATION FOR LISTED BUILDING CONSENT

I am directed by the Secretary of State for the Environment to refer to your letter of 12 August 1992 regarding your application for listed building consent for the updating of electrics and alterations to the box office at The Old Town Hall, High Street, Hemel Hempstead, Hertfordshire. The application was made in accordance with the provisions of Section 82 of the Planning (Listed Buildings and Conservation Areas) Act 1990.

The information submitted with your Council's application has been considered and the comments of the Hertfordshire Building Preservation Trust have been noted. The Secretary of State is satisfied that the works are acceptable in so far as the character of this building of special architectural or historic interest is concerned. Accordingly he hereby grants listed building consent for the updating of electrics and alterations to the box office at The Old Town Hall, Hemel Hempstead, Hertfordshire as referred to in application number 4/0710/92DL dated 10 June 1992, and as shown on the accompanying drawing, number 15/01/33/13 (as amended), subject to the following conditions:-

- i) The works hereby permitted shall be begun within 5 years from the date of this letter;
- ii) Details of the timber framework and glazing bars to both the existing and new hatch should be at a scale of not less than 1:20.
