REASONS FOR REFUSAL APPLICABLE TO APPLICATION: 4/00791/98/FUL

Date of Decision: 18 June 1998

- 1. The site is within the Metropolitan Green Belt on the adopted Dacorum Borough Local Plan wherein permission will only be given for use of land, the construction of new buildings, changes of use of existing buildings for agricultural or other essential purposes appropriate to a rural area or small scale facilities for participatory sport or recreation. No such need has been proven and the proposed development is unacceptable in terms of this policy.
- 2. The marquees introduce incongruous and out of scale additions to the walled garden which significantly detract from the appearance and setting of the Listed Building contrary to Policy 109 of the Dacorum Borough Local Plan.
