CONDITIONS APPLICABLE TO APPLICATION: 4/00809/99/FUL

1. This permission is for a limited period expiring on 30 June 2004. On or before this date, all the buildings on the site shall be removed.

Reason: To enable the local planning authority to retain control over the development, which is permitted only to meet the particular circumstances of the applicant.

2. Notwithstanding the details specified on Plan/Paper No. 7, within 6 weeks of the date of this decision full details of all proposed planting, and the proposed times of planting, shall be submitted for the approval of the local planning authority, and all planting shall be carried out in accordance with the approved details and times.

<u>Reason</u>: To ensure a satisfactory appearance to the development and to safeguard the visual character of the immediate area.

3. The details submitted in accordance with condition 2 shall include a landscape management plan, including long term design objectives, management responsibilities and maintenance schedules for all landscaped areas.

<u>Reason</u>: To ensure a satisfactory appearance to the development and to safeguard the visual character of the immediate area.

4. The existing boundary fencing shown coloured green on Plan/Paper No. 2 shall be replaced within three years from the date of this decision in accordance with a scheme which shall first have been submitted to and approved in writing by the local planning authority. Thereafter the approved scheme shall be retained and no other fencing, walls or other means of enclosure shall be erected unless agreed in writing by the local planning authority.

<u>Reason</u>: To ensure a satisfactory development and to safeguard the visual character of the immediate area

5. No exterior lighting or alterations to the existing exterior lighting of the site shall take place unless details shall first have been submitted to and approved in writing by the local planning authority. All lighting shall be installed and thereafter retained fully in accordance with the approved details.

<u>Reason</u>: To ensure a satisfactory appearance to the development and to safeguard the visual character of the immediate area.
