TOWN AND COUNTRY PLANNING ACT 1971 - SECTION 271 TORN AND COUNTRY AMERITIES ACT 1974 - SECTION 7 APPLICATION FOR LISTED BUILDING CONSIST KINGS LANGLEY LODGE FARM, KINGS LANGLEY

- I am directed by the Secretary of State for the Environment to refer to your letter of 30 April 1975 and to say that he has considered the County Council's application for listed building consent to alter and restore the Old Farmhouse, Barns and Cottage, Langley Lodge, King's Langley and to demolish some adjoining farm buildings. The application was made in accordance with the provisions of Regulation 10 of the Town and Country Planning Listed Buildings and Buildings in Conservation Areas Regulations 1972 as amended by the Amendment Regulations 1974.
- The Secretary of State notes that the alterations are required to restore the Farshouse, barns and Cottage and that the buildings to be demolished are obsolete and beyond economical repair and that their retention would prejudice the restoration of the Old Farmhouse and adjoining Tithe barn. The Secretary of State has noted too he representations received from the Georgian Group and the Hertfordshire Society as a result of the public advertisement of the proposals and statutory consultations. The proposed works are acceptable insofar as the character of the buildings as being of special architectural or historic interest is concerned and the Secretary of State hereby grants listed building consent for the work of alteration to the Old Farmheuse barns and cottage Langley Lodge, King's Langley and the demolition of the farm buildings edged red and delineated D on the submitted plan, all as known on drawing no 241/64/14/75 and the accompanying plans 329.5, 329.6, 329.7 and 329.8.
- Attention is drawn to Section 55(2)(b) of the 1971 Act whereby demolition may not be undertaken (despite the terms of this consent) until notice of the proposal has been given to the Royal Commission on Historic Monuments, Fortress House, 23 Savile Row. London WIX 2AA, and the Commission subsequently have either been given reasonable access to the buildings, or have stated that they have completed their record of the building or that they do not wish to record it.
- 4. This letter does not convey any consent or approval required under any enactment. bye-law, order or regulation other than sections 55 and 56 of the Town and Country Planning Act 1971.
