In pursuance of their powers under the above-mentioned Acts and the Orders and Regulations for the time being in force thereunder, the Council hereby refuse the development proposed by you in your application dated 20th June, 1979, and received with sufficient particulars on 22nd June, 1979, and shown on the plan(s) accompanying such application.

The reasons for the Council's decision to refuse permission for the development are:—

1. The site is allocated for primarily industrial purposes on the approved County Development Plan and Hertfordshire 1981. The proposed office use does not accord with that allocation and is therefore unacceptable in principle. Furthermore, there is clear evidence that there is only a limited amount of land available in the West Herts. Policy Area, as defined in the submitted County Structure Plan Written Statement, to meet the future needs of established industrial firms that need to remain in the County and the proposed development is unacceptable in that it will further deplete the industrial commitment.
2. Policy 6 of the submitted County Structure Plan Written Statement states that office development will be restricted to existing commitments for office development at 1st January, 1976 and the site which forms the subject of this application is not so committed. Notwithstanding this, the policy of the Local Planning Authorities seeks to restrict office development principally to offices serving the local community in Hertfordshire or to offices essential as ancillary services to industry established in the County and Steenson, Varming, Mulcahy & Partners, the proposed occupants of this building, are unacceptable in terms of this policy.

NOTE

- (1) If the applicant wishes to have an explanation of the reasons for this decision it will be given on request and a meeting arranged if necessary.
- (2) If the applicant is aggrieved by the decision of the local planning authority to refuse permission or approval for the proposed development, or to grant permission or approval subject to conditions, he may appeal to the Secretary of State for the Environment, in accordance with section 36 of the Town and Country Planning Act 1971, within six months of receipt of this notice. (Appeals must be made on a form which is obtainable from the Secretary of State for the Environment, Whitehall, London, S.W.1.) The Secretary of State has power to allow a longer period for the giving of a notice of appeal but he will not normally be prepared to exercise this power unless there are special circumstances which excuse the delay in giving notice of appeal. The Secretary of State is not required to entertain an appeal if it appears to him that permission for the proposed development could not have been granted by the local planning authority, or could not have been so granted otherwise than subject to the conditions imposed by them, having regard to the statutory requirements, to the provisions of the development order, and to any directions given under the order.
- (3) If permission to develop land is refused, or granted subject to conditions, whether by the local planning authority or by the Secretary of State for the Environment and the owner of the land claims that the land has become incapable of reasonably beneficial use in its existing state and cannot be rendered capable of reasonably beneficial use by the carrying out of any development which has been or would be permitted, he may serve on the District Council in which the land is situated, a purchase notice requiring that council to purchase his interest in the land in accordance with the provisions of Part IX of the Town and Country Planning Act 1971.
- (4) In certain circumstances, a claim may be made against the local planning authority for compensation, where permission is refused or granted subject to conditions by the Secretary of State on appeal or on a reference of the application to him. The circumstances in which such compensation is payable are set out in section 169 of the Town and Country Planning Act 1971.
