1. This permission relates only to the use for physiotherapy treatment and related techniques of that part of the ground floor of 6 Barncroft Road, Berkhamsted shown outlined in red on the approved drawings.

<u>Reason</u>: To safeguard the residential amenity of the area and to enable the local planning authority to retain control over the use which is permitted only to meet the specific circumstances of the applicant.

2. Not more than two therapists together with one administrative support staff member shall operate from the premises at any one time.

<u>Reason</u>: To safeguard the residential amenity of the area and to enable the local planning authority to retain control over the use which is permitted only to meet the specific circumstances of the applicant.

3. The use to which this permission relates shall cease when Mrs R M Lovesey ceases to practice physiotherapy treatment and related techniques on the premises. Thereafter, that part of the ground floor referred to in Condition 1 above shall be used only for residential purposes (or for purposes which are wholly incidental thereto) as part of the dwelling known as 6 Barncroft Road, Berkhamsted.
