1. The retail floorspace hereby permitted shall not enure for the benefit of the land and the use hereby permitted shall cease when the gun club, incorporating pistol shooting and clay pigeon shooting, ceases to occupy the land.

Reason: To enable the local planning authority to retain control over the development which is permitted only to meet the specific circumstances of the applicant, since a general retail use would not normally be considered acceptable in a rural area.

2. The three storage containers marked 1, 2 and 3 on plan number 4/0993/92 shall be removed from the site on or before 31 December 1993, and no further storage containers shall be brought onto the site.

Reason: The building to which this permission relates was originally permitted to provide all the necessary storage area for the site. The local planning authority has been satisfied that there is adequate storage accommodation available within existing buildings on the site and there is no justification for the retention of the three containers once storage reorganisation has been carried out.

3. The retail floorspace hereby permitted shall be used solely as a gun shop, the sale of goods being restricted to those specified in the attached 'Schedule of Goods' or such others as may be agreed in writing with the local planning authority:

Schedule of Goods

- 3.1 Shotguns, rifles and pistols.
- 3.2 Ammunition (ball and shot) self-loading equipment.
- 3.3 Clays/traps/targets.
- 3.4 Waterproof equipment/shooting vests/waistcoats.
- 3.5 Cleaning equipment/spare parts/repair equipment.
- 3.6 Game bags/cartridge bags/cartridge belts.
- 3.7 Gun slips/gun cases/holsters/shooting sticks.
- 3.8 Gun security cabinets.
- 3.9 Decoys/camouflage netting.

- 3.10 Gun dog/shooting instruction equipment.
- 3.11 Ear protectors.
