

PLANNING (LISTED BUILDINGS AND CONSERVATION AREAS) ACT 1990 - SECTION 13 APPLICATION FOR LISTED BUILDING CONSENT

- 1. I am directed by the Secretary of State for the Environment to refer to your letter of 25 September 1990 regarding your application for listed building consent for the formation of access stairs, doorway and installation of seating at The Old Town Hall, High Street, Hemel Hempstead, Hertfordshire. The application was made in accordance with the provisions of Section 13 of the Planning (Listed Buildings and Conservation Areas) Act 1990.
- 2. The information submitted with your Council's application has been considered and the comments of the Hertfordshire Building Preservation Trust have been noted. The Secretary of State is satisfied that the works are acceptable in so far as the character of this building of special architectural or historic interest is concerned. Accordingly he hereby grants listed buildings consent for the formation of access stairs, doorway and installation of seating at The Old Town Hall, High Street, Hemel Hempstead, Herts as referred to in application number 4/0996/90DL dated 28 June 1990 and as shown on the accompanying drawings numbers 15/01/33, 15/01/33/13,E/33/8, A43-01-101 and A43-01-102 subject to the following conditions -
 - (i) the works hereby permitted shall be begun within 5 years from the date of this letter;
 - (ii) the door shall be constructed in panels rather than by the use of applied mouldings.
- 3. This letter does not convey any approval or consent required under any enactment, bye-law, order or regulation, other than Sections 8 and 60 of the Planning (Listed Buildings and Conservation Areas) Act 1990.
