

Brief description and location of proposed development.

Subject to compliance with the following conditions:-

- (1) The development hereby permitted shall be constructed in L.B.C. Georgian facing bricks and Marley Yeoman Antique Brown roof tiles.
- (2) No work shall be started until a comprehensive scheme of landscaping, including existing trees, for the site shall have been submitted to, and approved by, the local planning authority. This landscaping scheme shall be implemented strictly in accordance with the approved details in the first planting season following the occupation of the development and shall be maintained at all times thereafter to the reasonable satisfaction of the local planning authority.

- (3) The gradient of the driveway shall be not greater than 1 in 30 for the first 4.5 m from the edge of the carriageway and thereafter; not greater than 1 in 10.
- (4) The development hereby permitted shall not be occupied until the land hatched green on plan 4/1009/85 shall have been cleared of all obstruction more than 0.6 m above carriageway level and kept clear at all times thereafter.

- (1) If the applicant wishes to have an explanation of the reasons for this decision it will be given on request and a meeting arranged if necessary.
- (2) If the Applicant is aggrieved by the decision of the local planning authority to approve the details of the proposed development subject to conditions, he may by notice served within one month of receipt of this notice, appeal to the Secretary of State for the Environment in accordance with Section 36 of the Town and Country Planning Act, 1971. The Secretary of State has power to allow a longer period for the giving of a Notice of Appeal and he will exercise his power in cases where he is satisfied that the applicant has deferred the giving of notice because negotiations with the local planning authority in regard to the proposed development are in progress.
