1. The works for which this consent is granted shall be begun before the expiration of five years from the date of this consent.

Reason: To comply with section 18 of the Planning (Listed Building and Conservation Areas) Act 1990.

2. No works shall be carried out until samples of the materials to be used in the construction of the external surfaces of the works hereby authorised shall have been submitted to and approved in writing by the local planning authority. The works shall be carried out in accordance with the approved details.

Reason: To safeguard the character and appearance of the listed building.

3. All new rainwater goods shall be in cast iron and painted black unless otherwise agreed in writing by the local planing authority.

Reason: To safeguard the character and appearance of the listed building.

4. Details of the windows in the new "shopfront", including sections through the glazing bars, frames and pilasters at a scale of 1:5, shall be submitted to and approved in writing by the local planning authority prior to any commencement of works, and the windows shall be installed in accordance with the approved details.

Reason: To safeguard the character and appearance of the listed building.

5. Interior elevations showing details of new skirting, panelling, dado rail and picture rails shall be submitted to and approved by the local planning authority prior to the commencement of any works hereby authorised.

<u>Reason</u>: In the interests of safeguarding the appearance and character of the listed building.

6. Notwithstanding the details shown on Drawing No. ADJ/TB/07A, the existing front door to the Bell Public House shall be retained unless otherwise agreed in writing by the local planning authority.

Reason: To safeguard the character and appearance of the listed building.

7. The colour of the paint work for the new shopfront shall be agreed in writing prior to works commencing and it shall be retained in the colour so approved.

Reason: In the interests of preserving the appearance and character of the listed building.

8. All new glazing shall consist of 'Pyrostop' or similar clear safety glass, and,

notwithstanding the details shown on the approved plans, no Georgian wired glass shall be used unless agreed in writing by the local planning authority.

Reason: To safeguard the appearance and character of the listed building.

9. Notwithstanding the details on the approved plans, all rainwater goods shall either be aluminium or cast iron.

Reason: In the interests of the character and appearance of the listed building.
