## PLANNING (LISTED BUILDINGS AND CONSERVATION AREAS) ACT 1990 - SECTION 82 APPLICATION FOR LISTED BUILDING CONSENT

I am directed by the Secretary of State for the Environment to refer to your letter of 26 October 1993 regarding the application made by the Director of Leisure services of Dacorum Borough Council for listed building consent in respect of increasing external lighting to building front elevation at the Old Town Hall, Hemel Hempstead, Hertfordshire. The application was made in accordance with the provisions of Section 82 of the Planning (Listed Buildings and Conservation Areas) Act 1990.

The information submitted with your Council's application has been considered including the comments made by the Hertfordshire Building Preservation Trust. It is noted that no further representations were received as a result of public advertisement of the proposals. The Secretary of State is satisfied that the works are acceptable in so far as the character of this building of special architectural or historic interest is concerned. Accordingly he hereby grants listed building consent in respect of increasing external lighting to building front elevation at the Old Town Hall, Hemel Hempstead, Hertfordshire as referred to in application number 4/1101/93DL dated 28 June 1993, and as shown on the accompanying drawing, number 15/01/33/6 subject to the following condition:-

- i) the works hereby permitted shall be begun within 5 years from the date of this letter.

This letter does not convey any approval or consent required under any enactment, bye-law, order or regulation, other than Sections 8 and 60 of the Planning (Listed Buildings and Conservation Areas) Act 1990.
