3 Notwithstanding the provisions of the Town and Country Planning (General Permitted Development) Order 1995 (or any Order revoking or re-enacting that Order) (with or without modification) (Schedule 2 Part 1 Class F), no hard surface for the parking of vehicles shall be formed within the area hatched green on Drawing No. Wren/NAJ/061/00 without the prior written approval of the local planning authority.

<u>Reason</u>: To enable the local planning authority to retain control over the development in the interests of safeguarding the the appearance of the street scene on this prominent corner.
