Application Number 4/01148/97/FUL**


The above application is due to be heard before the Planning Committee on Thursday, 16th October 1997.

However, points of concern have been raised at the last moment by the Planning and Highways departments, and we feel that we have not been afforded enough time to try to answer those in detail.

We believe it of primary importance that the Committee has enough information at hand to be able to fully evaluate the proposal. To that end, we are beginning to prepare information on anticipated traffic flow to the site, historical evidence on the traffic situation relating to the existing commercial usage on the site, and additional supporting background information from the vendors.

As a result, we would respectfully **request withdrawal** of the current application, with a view to re-submit with additional information at our earliest opportunity.
