2. A replacement tree shall be planted for the Sycamore tree in the first planting season following removal of the existing tree. The replacement shall be planted in the vicinity of the existing tree and shall be a standard in size ie 2.75 - 3 m overall height and 8 - 10 cm girth at 1m above ground level.

The replacement shall be one of the following species unless otherwise agreed with the Local Planning Authority.

- (i) Malus tscheroskii (Pillar Apple)
- (ii) Sorbus aucuparia (Rowan)
- (iii) Prunus subhirtella 'Autumnalis' (Winter Cherry).
