- (a) Application for approval in respect of all matters reserved in Condition 1 above shall be made to the local planning authority within a period of .3. years commencing on the date of this notice. 2
 - (b) The development to which this permission relates shall be begun by not later than whichever is the later of the following dates:-

 - (i) the expiration of a period of .5. years, commencing on the date of this notice.
 (ii) the expiration of a period of .2. years commencing on the date upon which final approval is given by the local planning authority or by the Secretary of State or, in the case of approval given on different dates, the final approval of the last such matter to be approved by the local planning authority or by the Secretary of State.
- This permission shall not extend to any of the details shown on plan 4/1192/77 3. and is limited to the principle of providing such facilities.
