He does not in practice refuse o entertain appeals solely because the decision of the local planning authority was based on a direction given by him. If permission to develop land is refused or granted subject to conditions, whether by the local planning authority or by the

Secretary of State for the Environment, and the owner of the land claims that the land has become incapable of reasonably beneficial ise in its existing state and cannot be rendered capable of reasonably beneficial use by the carrying out of any development which has seen or would be permitted he may serve on the Common Council, or on the Council of the county borough, London borough or county

- district in which the land is situated, as the case may be, a purchase notice requiring that council to purchase his interest in the land in ecordance with the provisions of Part IX of the Town and County Planning Act 1971. In certain circumstances, a claim may be made against the local planning authority for compensation, where permission is efused or grented subject to conditions by the Secretary of State on appeal or on a reference of the application to him. The circumstances n which such compensation is payable are set out in section 169 of the Town and Country Planning Act 1971.
- The statutory requirements are those set out in section 36(7) of the Town and Country Planning Act 1971, namely sections 29(1), 30(1), 67 and 74 of the Act.
