I refer to the above appeal by Mr P Chan against the Enforcement Notice served by the Borough Council requiring the removal of a boundary fence.

You will no doubt be aware that Mr Chan lodged a separate planning appeal under Section 78 of the Act (your reference APP/A1910/A/93/226427) and that that appeal was allowed on 29 September 1993.
