1. The works for which this consent is granted shall be begun before the expiration of five years from the date of this consent.

Reason: To comply with section 18 of the Planning (Listed Building and Conservation Areas) Act 1990.

2. The works shall be carried out in accordance with the Schedule of Materials submitted on 2 September 1998 [reference JD/CAB] and shall match exactly those materials used on the adjoining classroom block for which listed building consent was granted on 10 September 1997 under reference 4/1175/97LBC.

Reason: To safeguard the character and appearance of the Listed Building.

3. Details of the type and colour of the mortar shall be submitted to and approved in writing by the local planning authority prior to commencement of works, and the works shall be carried out in accordance with the details as approved.

Reason: To safeguard the character and appearance of the Listed Building.

4 All windows, bargeboards and finials shall be constructed in timber and painted white, unless otherwise agreed in writing by the local planning authority.

Reason: To safeguard the character and appearance of the Listed Building.

5. Notwithstanding the details submitted, details of the roof lights shall be submitted to and approved in writing by the local planning authority prior to their installation. The works shall be carried out in accordance with the approved details.

Reason: To safeguard the character and appearance of the Listed Building.

6. Details of the windows, including the glazing, doors, steps and railings shall be submitted to and approved in writing by the local planning authority prior to the commencement of works. The works shall be carried out in accordance with the approved details.
