3. Notwithstanding the provisions of the Town and Country Planning (General Permitted Development) Order 1995 (or any Order revoking or re-enacting that Order) (with or without modification), no windows, dormer windows, doors or other openings other than those expressly authorised by this permission shall be constructed in the north elevation of the development hereby permitted.

<u>Reason</u>: In the interests of the residential amenities of the occupants of the adjacent dwellings.

4 The new windows to be inserted within the north (side) elevation of the extensions hereby permitted shall be permanently fitted with obscured glazing and shall be non-opening.
