**PROPOSED RETENTION OF FIVE MOBILE CLASSROOM UNITS
TRING SCHOOL, MORTIMER HILL, TRING
Three conditions to be attached to planning permission (4/1310-97)**

1. **TIME LIMIT - UNITS 2 AND 4**

Planning permission for the retention of units two and four, as identified on submitted drawing number RJC/TR/1, shall be for a limited period until four weeks after completion of the current building works permitted reference 4/86-97 or until 31 July 1998, whichever is the earlier, by which time the buildings shall be removed and the land cleared and reinstated to the satisfaction of the County Planning authority.

Reason : In the interest of amenity by enabling the County Planning Authority to exercise proper control over development on the site.

2. **TIME LIMIT - UNIT 1**

Planning permission for the retention of unit one, as identified on submitted drawing number RJC/TR/1, shall be for a limited period of two years expiring on 31 October 1999, by which time the building shall be removed and the land cleared and reinstated to the satisfaction of the County Planning authority.

Reason : In the interest of amenity by enabling the County Planning Authority to exercise proper control over development on the site.

3. **TIME LIMIT - UNITS 3 AND 5**

Planning permission for the retention of units three and five, as identified on submitted drawing number RJC/TR/1, shall be for a limited period of five years expiring on 31 October 2002, by which time the buildings shall be removed and the land cleared and reinstated to the satisfaction of the County Planning authority.

Reason : In the interest of amenity by enabling the County Planning Authority to exercise proper control over development on the site.
