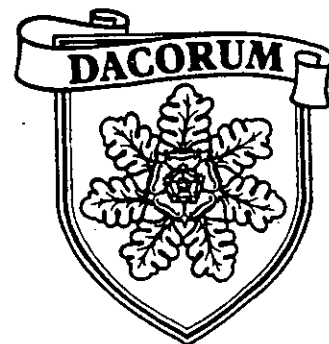

I WOULD BE GRATEFUL IF YOU WOULD WITHDRAW THE ABOVE APPLICATION (SCHEDULED FOR COMMITTEE 06/03/97) FOLLOWING OR EARLIER TELECON. & PENDING FURTHER DISCUSSIONS.

I FEEL THAT THE IMPLICATION WHICH HAS BEEN DRAWN FROM THE BUILDING CONTROL RESPONSE TO THE HEADS OF ESCAPE ISSUE, WOULD RESULT IN THE DESTRUCTION OF THE INTERNAL VALUE OF THIS BARN, WHICH HAS BEEN CONSCIOUSLY RETAINED, AT THE EXPENSE OF FLOOR SPACE. IT APPEARS THAT THE OVERRIDING INTENTION WITH ALL BARN CONVERSIONS, TO RETAIN THE EXISTING CHARACTER & INTERNAL VALUES, HAS BEEN OVERLOOKED.

MAY I REQUEST THAT IN THE PRESENCE OF THE MICRO DETAILING OF THIS BARN THE OVERRIDING CONCERNS & 'PLANNING' INTENTIONS, TO PRODUCE A SUCCESSFUL CONVERSION, HAVE BEEN OVERLOOKED. "THE PLOT HAS BEEN LOST" AS IT WERE.

I FIND THIS ATTITUDE VERY DISAPPOINTING & FEEL THAT DESPITE OUR LENGTHY & EXHAUSTIVE ATTEMPTS TO RESOLVE THESE ISSUES, THIS ELEVENTH HOUR CLARIFICATION LEAVES US WITH NO MEANINGFUL ALTERNATIVE BUT TO WITHDRAW THE APPLICATION.
