TOWN AND COUNTRY PLANNING ACT 1971 - SECTION 271 TOWN AND COUNTRY AMENITIES ACT 1974 - SECTION 7 APPLICATION FOR LISTED BUILDING CONSENT THE BURY, QUEENSWAY, HENEL HEMPSTEAD

- 1. I am directed by the Secretary of State for the Environment to refer to your letter of 11 December 1981 regarding the County Council's application for listed building consent for minor internal alterations and installation of fittings, and erection of temporary office building in grounds at The Bury, Queensway, Hemel Hempstead. As the proposed temporary office building appears to be a free-standing structure, its erection does not require listed building consent. The application was made in accordance with the provisions of Regulation 11 of the Town and Country Planning (Listed Buildings and Buildings in Conservation Areas) Regulation 1977.
- 2. The information submitted with the County Council's application has been considered and it is noted that no objections were received following the public advertisement of the proposals. The comments of the Dacorum District Council have been noted. The Secretary of State is satisfied that the proposed works are acceptable in so far as the character of The Bury as a building of special architectural or historic interest is concerned, and accordingly, he hereby grants listed building consent for the works of alteration at The Bury, Queensway, Hemel Hempstead as referred to in the Council's application form dated 6 November 1981 (reference 4/1395-81 LB CC) and in accordance with the accompanying drawing CB 45. MW2.81 subject to the condition that the works hereby permitted shall be begun not later than five years from the date of this letter.
- 3. This letter does not convey any approval or consent required under any enactment, bye-law, order or regulation, other than Sections 55 and 56 of the Town and Country Planning Act 1971.
- 4. A copy of this letter is being sent to Dacorum District Council.
