1. INITIAL LANDSCAPING

Before phase 1 of the development hereby permitted is occupied or within the first available planting season after its completion, all the landscaping shown on drawing number W/0130/01/LA shall be carried out to the satisfaction of the County Planning Authority. However, should work on phase 2 be intended to start within three years of the completion of phase 1, then the landscaping shall be limited to that along the southeastern side, together with than on the opposite site in the corner by the sixth form block, and for the interim period the grassed area adjacent to the rest of the phase 1 extension shall be re-instated. Any shrub which dies or is severely damaged within five years of planting shall be replaced during the first available planting season to the satisfaction of the County Planning Authority.

Reason: To ensure adequate and satisfactory landscaping of the site in the interests of the amenity of the area, whether or not phases 2 and 3 are constructed.

2. FULL LANDSCAPING

Phase 2 of the development hereby permitted shall not be commenced until full details of the landscaping indicated on drawing number 1276/A/SK/350, including new tree and/or shrub planting, seeding, paving and treatment of hard surfaces has been submitted to and approved in writing by the County Planning Authority, such a scheme to provide for species, siting, specification and programme of planting. All landscaping required by the scheme shall, unless the approved scheme provides otherwise, be completed before any part of phase 2 is occupied or within the first available planting season thereafter. Any tree or shrub which dies or is severely damaged within five years of planting shall be replaced during the first available planting season to the satisfaction of the County Planning Authority.

Reason: To ensure adequate and satisfactory landscaping of the site in the interests of the amenity of the area if phases 2 and 3 are constructed.

3. REMOVAL OF MOBILE CLASSROOM UNITS

Upon completion of phase of the development hereby permitted, at least one single and one more double mobile classroom units shall be removed from the site and, if phase 2 of the development does not follow on immediately, the land reinstated to the satisfaction of the County Planning Authority.

Reason: To ensure, in the interests of amenity, that a start is made on the phased removal of the mobile units from the site, planning permission for all the units in any case expiring on 31 July 1997.
