The farm shop and farm animals (other than hens) that were introduced onto the site in and after 1981 were initially uses that were either ancillary to or formed part of the primary use of the site for agricultural purposes.

During the period from 1984, when entrance charges were first levied, to 1988, when egg production ceased, the character and scale of these new uses changed from being ancillary to or primarily agricultural uses to recreational and educational uses. Since 1988, the uses carried on at the site have depended for their existence on educational and recreational visits to the site rather than on the breeding and keeping of livestock.

The local planning authority is of the opinion that this has resulted in a material change of use on the site, for which planning permission was required but was not obtained. The existing uses at the site cannot therefore be regarded as lawful, as less than ten years have elapsed since this material change of use occurred.
