## PLANNING (LISTED BUILDING AND CONSERVATION AREAS) ACT 1990 APPLICATION FOR LISTED BUILDING CONSENT

- I am directed by the Secretary of State for the Environment, Transport and the Regions to refer to your letter of 4 January 2000 regarding Dacorum Borough Council's application for listed building consent for the installation of a wall mounted heritage style CCTV camera at Black Horse Agencies at 16 High Street, Tring, Hertfordshire. The application was made in accordance with the provisions of Section 82 of the Planning (Listed Buildings and Conservation Areas) Act 1990.
- The information submitted by Dacorum Borough Council has been considered and the comments of English Heritage and Tring Parish Council have been noted.
- The Secretary of State is satisfied that the works are acceptable in so far as the character of this building of special architectural interest is concerned. Accordingly he hereby grants listed building consent for the installation of a wall mounted heritage style CCTV camera at Black Horse Agencies at 16 High Street, Tring, Hertfordshire as referred to in application number (4/1505/99) dated 25 August 1999 subject to the conditions that:
  - the works hereby permitted shall be begun within 5 years from the date of this letter.
  - details of the works shall be submitted and agreed with Dacorum Borough Council's Conservation Officer prior to commencement of the works.
