1. The development hereby permitted shall be begun before the expiration of five vears from the date of this permission.

Reason: To comply with the requirements of Section 91 (1) of the Town and Country Planning Act 1990.

2. This planning permission only relates to the Strand 'A' CCTV Lantern Videmech Enclosure and wall bracket design as shown on Drawing No. 0640 received by the local planning authority on 13 January 1998.

Reason: In the interests of the character and appearance of the Listed Buildings and Hemel Hempstead Conservation Area and for the avoidance of doubt.



3. The wall bracket and upper hemisphere component of the Strand Lantern shall be painted black at all times.

Reason: In the interests of the character and appearance of the Listed Buildings and the Hemel Hempstead Conservation Area and for the avoidance of doubt.

4. All cabling shall be of the same colour as the building surfaces to which the cabling is attached and the precise route of the cabling shall be to the satisfaction of the local planning authority.

Reason: In the interests of the character and appearance of the Listed Buildings and Hemel Hempstead Conservation Area and for the avoidance of doubt.

5. Details of the position, design and size of the control boxes/pillar shall be submitted to and approved in writing by the local planning authority before the cameras hereby permitted are installed. The boxes shall be installed in accordance with the approved details and thereafter there shall be no changes to the control boxes unless otherwise agreed in writing by the local planning authority.



Reason: In the interests of the character and appearance of the Listed Buildings and Hemel Hempstead Conservation Area and for the avoidance of doubt.

6. This planning permission does not extend to the installation of the camera at No.14 Queensway, Hemel Hempstead.

Reason: For the avoidance of doubt, as planning permission is not required for the installation of a camera in this location.
