(2) If the applicant is aggrieved by the decision of the local planning authority to refuse permission or approval for the proposed development, or to grant permission or approval subject to conditions, he may appeal to the Secretary of State for the Environment in accordance with section 36 of the Town and Country Planning Act 1971 within six months of receipt of this notice. (Appeals must be made on a form which is obtainable from the Department of the Environment, Caston House, Tothill Street, London SW1H 9LZ) The Secretary of State has power to allow a longer period for the giving of a notice of appeal but he will not normally be prepared to exercise this power unless there are special circumstances which excuse the delay in giving notice of appeal. The Secretary of State is not required to entertain an appeal if it appears to him that permission for the proposed development could not have been granted by the local planning authority, or could not have been so granted otherwise than subject to the conditions imposed by them, having regard to the statutory requirements (a), to the provisions of the development order, and to any directions given under the order. He does not in practice refuse

to entertain appeals solely because the decision of the local planning authority was based on a direction given by him.

(3) If permission to develop land is refused or granted subject to conditions, whether by the local planning authority or by the Secretary of State for the Environment, and the owner of the land claims that the land has become incapable of reasonably beneficial use in its existing state and cannot be rendered capable of reasonably beneficial use by the carrying out of any development which has been or would be permitted he may serve on the Common Council, or on the Council of the county borough, London borough or county district in which the land is situated, as the case may be, a purchase notice requiring that council to purchase his interest in the land in accordance with the provisions of Part IX of the Town and County Planning Act 1971.

(4) In certain circumstances, a claim may be made against the local planning authority for compensation, where permission is refused or granted subject to conditions by the Secretary of State on appeal or on a reference of the application to him. The circumstances in which such compensation is payable are set out in section 169 of the Town and Country Planning Act 1971.

- 4 Details of the ground floor levels of the buildings in relation to existing and proposed highways shall be submitted to and approved by the local planning authority before development is commenced.
- The access shall include the provision of sight lines 2.4 m \times 70 m with kerb radii of 10.5 within which there shall be no obstruction more than 600 mm above carriageway level.
- The development hereby permitted shall not be occupied until the sight lines referred to in condition 5 shall have been provided, and they shall be maintained at all times thereafter.
- 7 The kerb radii of the access shall include a pram/wheelchair crossing.
- The road hereby permitted shall be constructed in accordance with the specification of the Hertfordshire County Council set out in "Residential Roads in Hertfordshire".
 - (NOTE: Full details of the road works proposed should be submitted to and approved by the local highway authority before any work is commenced on site.)
- Details submitted in accordance with condition I of this permission shall include a tree survey of the site recording the species, height, crownspread, bole diameter, age and condition of all the trees, and the height and spread of all the hedgerows located on the site, indicating on the proposed layout plan those trees and hedges which it is proposed to remove and those which it is proposed to retain.
- The existing hedge on the southern and western boundaries of the site shall be protected during the period of construction and such part or parts of the hedge as become damaged shall be replaced within the planting season following completion of development.
- This permission shall not extend to any of the details shown on Drawing No 1590/01, which shall be regarded as for illustrative purposes only.
- The garaging, parking and circulation facilities referred to in condition (1) and (3) hereof shall be laid out in accordance with such plans as are approved and those areas shall not be used thereafter for any purpose other than the parking or manoevering of vehicles.
