- (1) If the Applicant is aggrieved by the decision of the local planning authority to refuse permission or approval for the proposed development, or to grant permission or approval subject to conditions, he may by notice served within one month of receipt of this notice, appeal to the Minister of Housing and Local Government in accordance with Section 16 of the Town and Country Planning Act, 1947. The Minister has power to allow a longer period for the giving of a Notice of Appeal and he will exercise his power in cases where he is satisfied that the applicant has deferred the giving of notice because negotiations with the local planning authority in regard to the proposed development are in progress. The Minister is not, however, required to entertain such an appeal if it appears to him that permission for the proposed development could not have been granted by the local planning authority, or could not have been so granted otherwise than subject to the conditions imposed by them, having regard to the provisions of Section 14 of the Act and of the Development Order and to any directions given under the Order.
- (2) If permission to develop land is refused, or granted subject to conditions, whether by the local planning authority or by the Minister of Housing and Local Government, and the owner of the land claims that the land has become incapable of reasonably beneficial use in its existing state and cannot be rendered capable of reasonably beneficial use by the carrying out of any development which has been or would be permitted, he may serve on the Council of the County Borough or County District in which the land is situated a purchase notice requiring that Council to purchase his interest in the land in accordance with Section 19 of the Town and Country Planning Act, 1947.
- (3) In certain circumstances, a claim may be made against the local planning authority or the Minister of Housing and Local Government for compensation, where permission is refused, or granted subject to conditions by the Minister on appeal or on a reference of the application to him. The circumstances in which such compensation is payable are set out in Section 20 of the Town and Country Planning Act, 1947, and Part II of the Town and Country Planning Act, 1954.


- 1. I am directed by the Minister of Housing and Local Government to say that he has considered the report of his Inspector, Mr. L. Cook Hall, A.M.I.Mun.E., M.T.F.I., A.R.S.H., on the local inquiry into your client's appeal against the decision of the Berkhamsted Rural District Council, acting on behalf of the Hertfordshire County Council, to refuse permission for residential development on land 0.S.375 and 376 at Wilstone, Hertfordshire.
- 2. The Inspector, a copy of whose report is enclosed, recommended that your client's appeal be dismissed for the following reasons:-
 - (1) The site formed part of the proposed green belt;
 - (2) there were no special circumstances to justify residential development of the appeal site;
 - (3) provision for this type of development had been made in the Town Maps.
- 3. The Minister agrees generally with his Inspector's views. While development on the scale proposed could not be regarded as infilling or rounding off of the village, he agrees with the Council that 3 dwellings on the eastern frontage of the site would be reasonable as this would not harm the character of the village or impair the value of the proposed green belt in this area. He therefore dismisses your client's appeal without prejudice to the consideration by the local planning authority of a fresh application for development of the frontage on the lines indicated.
