1. Car parking facilities to the extent already existing on the site shall be maintained at all times to the satisfaction of the local planning authority.
2. The use of the premises shall be limited to light industry as defined in Class III of Schedule to Use Classes Order 1963 and for no other purpose and be not detrimental to amenities by reason of noise, vibration, smell, fumes, smoke, soot, ash, dust or grit.

The permission referred to in this notice does not constitute:

- (i) A passing of plans or a consent for the purposes of the Public Health Acts 1936 and 1961; and the Building Regulations 1965.
- (ii) A consent under the Public Health (Drainage of Trade Premises) Act 1937.
- (iii) An approval under the Clean Air Act 1956; and the Thermal Pollution Act 1957.
- (iv) A consent under Section 75 of the Highways Act 1959.

The reasons for the Council's decision to grant permission for the development subject to the above conditions are:—

1. To comply with the car parking standards adopted by the local planning authority.
2. To protect the amenities of the adjoining residential property.

The Minister has power to allow a longer period for the giving of a Notice of Appeal and he will exercise his power in cases where he is satisfied that the applicant has deferred the giving of notice because negotiations with the local planning authority in regard to the proposed development are in progress. 
